4. The research methodology requires elaboration, including detailed procedures, a schematic diagram, and a structured plan of work.
5. The scholar must clearly demonstrate how this study differs from existing research, with specific reference to the cited literature.
6. **The following University format must be ensured in the revised synopsis:**
 - a. Title of the synopsis (topic) should be at the top of the title page and must be in 16-18 fonts while all other details should be below the Monogram and in 14-16 fonts
 - b. The Monogram should be one inch from all sides
 - c. Paper size should be selected as letter sized with Normal Margins (one inch from all sides),
